## **Personal**

• Your Social Security number or tax ID number

• Your spouse's full name and Social Security number or tax ID number

# Dependent(s)

- Dates of birth and Social Security numbers or tax ID numbers
- Childcare records (including the provider's tax ID number) if applicable
- Form 8332 showing that the child's custodial parent is releasing their right to claim a child to you, the noncustodial parent (if applicable)

#### <u>Income</u>

- Employed
  - o Forms W-2
- Unemployed
  - Unemployment (1099-G)
- Self-Employed

- o Forms 1099-MISC and 1099-K
- o Income records to verify amounts not reported on 1099s
- Records of all expenses check registers or credit card statements, and receipts
- Business-use asset information (cost, date placed in service, etc.) for depreciation
- Home office information, if applicable
- Record of estimated tax payments made (Form 1040ES)

#### Rental Income

- Records of income and expenses
- Rental asset information (cost, date placed in service, etc.) for depreciation
- Record of estimated tax payments made (Form 1040ES)

#### Retirement Income

- Pension/IRA/annuity income (1099-R)
- Traditional IRA basis (prior-year Forms 8606 showing amounts already taxed)
- Social Security/RRB income (SSA-1099, RRB-1099)

# Savings & Investments or Dividends

- o Interest, dividend income (1099-INT, 1099-OID, 1099-DIV)
- Income from sales of stock or other property (1099-B, 1099-S)
- Dates of acquisition and records of your cost or other basis in property you sold (if basis is not reported on 1099-B)
- Expenses related to your investments
- Record of estimated tax payments made (Form 1040ES)

#### Other Income & Losses

- State refunds (Form 1099-G)
- o Income from K-1s either as investment or as active owner
- Gambling income (W-2G or records showing income, as well as expense records)
- Jury duty records
- Hobby income and expenses
- Prizes and awards
- Trusts
- Royalties (1099 Misc.)
- Any other 1099s received
- Record of alimony paid/received with ex-spouse's name and SSN
- Health Savings Account and long-term care reimbursements (1099-SA or 1099-LTC)

#### **Deductions**

#### Home Ownership

- o Form 1098 or other mortgage interest statements
- Real estate and personal property tax records

#### Charitable Donations

- Cash amounts donated to houses of worship, schools, other charitable organizations
- o Records of non-cash charitable donations
- o Amounts of miles driven for charitable purposes

# Medical Expenses

- o Amounts paid for healthcare insurance and to doctors, dentists, hospitals
- Miles driven for medical purposes
- o Travel expenses for medical, including hotels, planes, tolls, parking, etc.

#### Health Insurance

- Form 1095-A if you have health insurance through a State Marketplace (Exchange)
- Form 1095-B and/or 1095-C if you had insurance coverage through any other source (e.g. an employer, insurance company, government health plan such as Medicare, Medicaid, CHIP, TRICARE, VA, etc.)
- Exemption certificate (ECN) if you applied for and received an exemption from your State Marketplace

#### Childcare Expenses

- Daycare paid for a child under age 13 so the taxpayer and spouse can work
- Wages paid to a babysitter

# Educational Expenses

- o Forms 1098-T from educational institutions
- Receipts for qualified educational expenses
- Records of scholarships or fellowships
- o Form 1098-E for student loan interest

### State & Local Taxes or Sales Tax

- Amount of state/local income tax paid (other than wage withholding), or amount of state and local sales tax paid
- Invoice showing amount of vehicle sales tax paid

- o Amount of real estate taxes paid
- o Amount of personal property taxes paid

# • Retirement & Other Savings

- o Form 5498-SA showing HSA contributions
- o Form 5498 showing IRA contributions
- o All other 5498 series forms (5498-QA, 5498-ESA)

# • Federally Declared Disaster

- o City/county you lived/worked/had property in
- o Records to support property losses (appraisal, clean-up costs, etc.)
- o Records of rebuilding/repair costs
- o Insurance reimbursements/claims to be paid
- o FEMA assistance information
